This agreement is made between Labrador Welfare and the Adopter named above.

The following terms and conditions shall apply to this agreement.

## 1. Ownership

For the purposes of this agreement, the term "adoption" means permission granted by Labrador Welfare for the Adopter to keep the dog at their home on the terms and conditions of this agreement.

## 2. My obligations as Adopter

- a. I will satisfy myself as to the suitability of the dog for me and the domestic environment into which I wish to keep it.
- b. If, at any time, I become unable to keep the dog, I will notify Labrador Welfare immediately and return the dog to them, or as they request.
- c. I will make provision for Labrador Welfare to be contacted in the event of my death and understand that they have sole responsibility for making arrangements for the future care of the dog in those circumstances.
- d. If I change the address at which I keep the dog, I will notify Labrador Welfare immediately and will also update my microchip information with the data base.
- e. I will feed, house and care for the dog to the reasonable satisfaction of Labrador Welfare.
- f. I will allow a representative of Labrador Welfare access to my home and to the dog upon reasonable notice to inspect the conditions in which the dog is kept.
- g. I will ensure that the dog is exercised regularly, under proper control and not permitted to be out alone.
- h. I will not leave the dog for extended periods without companionship.

- i. I will not chain the dog except as absolutely necessary, and then only combined with a running line.
- j. I will ensure that the dog has the benefit of qualified veterinary treatment in the event of injury or illness.
- k. I will ensure that all recommended vaccinations are undertaken annually.
- I. If not already neutered I will arrange for the dog to be spayed or neutered within twelve months of my adoption of the dog at my own expense, and will supply Labrador Welfare with details immediately afterwards.
- m. Any puppies born to a bitch in my care under this agreement shall be the property of Labrador Welfare who shall have sole responsibility for their re-homing.
- n. I will ensure that the dog wears a collar and identification disc bearing my address and telephone number at all times when it is not in my home.
- o. In the event that the dog becomes lost or is missing, I will immediately notify the microchip registration company, my local council dog warden and Labrador Welfare.
- p. I will comply with all laws and regulations from time to time relating to the registration of dogs.
- q. I will return the dog to Labrador Welfare at their request should they reasonably conclude that I have not complied with these terms and conditions.
- r. I have never been convicted of any offence under any legislation relating to the keeping of dogs.

## 3. Our obligations as Owners

- a. Subject to you complying with your obligations under this agreement, we will permit you to keep the dog in your care.
- b. Labrador Welfare gives no warranties and makes no representations as to the quality, fitness or temperament of the dog supplied, nor that it is suitable for any particular purpose or domestic environment.
- c. Labrador Welfare shall have no liability for any personal injury or property damage caused by the dog after the date of this agreement.
